- The bids will be opened in the presence of Bidders' representatives who choose to attend at 13.00 & 14:00. hours respectively on November 11, 2020 (i.e dated 2077/07/26) at the office of Sahidbhumi Rural Municipality, Dhankuta.
- If bidder wishes to submit Bid security in the form of cash, the cash should be deposited in deposited in deposit Account no. 0740100000004201 at Citizens Bank International Ltd, Dhankuta, on the account of Sahidbhumi Rural Municipality Office, Piple, Dhankuta. And submit the receipt of the deposited amount of cash along with the electronics bids.
