- 6. Electronic bids must be submitted through PPMO website <a href="www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a> on or before 12.00 noon on April 25, 2019. Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1.00 PM** on April 25, 2019 at the **office of the Rural Municipal Executive**, *Sahidbhumi*, *Piple*. Bids must be valid for a period of *90 days* after bid opening and must be accompanied by a scanned copy of the bid security in pdf format, amounting to a minimum of *NRs.* 7,82,000.00 (*Seven Lakhs Eightty Two Thousands*), which shall be valid for 30 days beyond the validity period of the bid.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
